

Regional MENA webinar on Data and Information-Sharing May 19 2022

I. SHORT SUMMARY

Open data has been described as the 'new raw material of the twenty-first century'. Its propensity to unleash social and economic benefits for citizens and economic actors has piqued the interest of public institutions around the world who are increasingly alert to the potential of releasing public information and data.

While governments and parliaments do have access to large stores of information, they struggle with prioritization of dissemination, or the quality of data. At the same time, there are challenges on the demand side, with the civic sector underutilizing the data and information available.

The conference on data and information-sharing, hosted by Lebanon, will gather stakeholders from four MENA countries: Tunisia, Jordan, Lebanon and Morocco. The event will allow civic actors, governmental and parliamentary institutions from all four countries to share their experiences and the challenges related to data and information-sharing.

II. OBJECTIVES

In the context of participating countries' efforts to advance the Open Government values, NDI proposes a 90-minute online discussion with the following objectives:

- To review and discuss current data release priorities of the state institutions
- To analyze the current information-sharing challenges of the regional institutions
- To discuss the role of civil society in creating a demand for data and information

The proposed event intends to engage all stakeholders in a discussion about the current achievement and to reflect on expectations for the future.
